- One Display table will be provided for each Street Fair Vendor / Two display tables will be provided for Pop-Up Tent Spaces
- Rain date for the Street Fair is Sunday, September 20. This is a rain or shine event. **NO REFUNDS.**
- A Certificate of Insurance or Signed Waiver is required prior to the event.

Recommendations: For your comfort, it is recommended that you bring a portable chair & a small shade cover.(see order form above) Permitted on Moger Ave are small portable clamp-on umbrellas -or- small 4x6 size Instant Shade Cover only. All shade coverings must be secured and weighted. You must reserve Pop-Up Market Space to erect a large 10x10 Pop-Up Tent. For pedestrian safety, no large tents are allowed on So. Moger Ave. sidewalks.
