- One Display table will be provided for each Street Fair Vendor / Two display tables will be provided for Pop-Up Tent Spaces
- Rain date for the Street Fair is Sunday, September 15. This is a rain or shine event. **NO REFUNDS.**
- A Certificate of Insurance or Signed Waiver is required prior to the event.

Recommendations: For your comfort, it is recommended that you bring a portable chair & a small shade umbrella. Permitted on Moger Ave are small portable clamp-on umbrellas -or- small 4x6 Ozark Trail Instant Shade only – (available at Walmart.) All shade coverings must be secured and weighted.
